Words of Welcome from the Highest Representative of Republic of China (Taiwan) in Germany

I am pleased to know that the German Federal Ministry of Education and Research has awarded four post-doctoral researchers funding for a four-year joint research project, “Taiwan als Pioneer (TAP)”, in which the University of Trier, the University of Tübingen and the University of Bochum will establish intra- and interdisciplinary networks over the next four years (February 2022 to January 2026), and in this way, Taiwan research will be sustainably anchored in the German academia.



Taiwan is often a focus and an issue in politics, and this aspect has been extensively researched or continues to be researched; however, there is much more than this that Taiwan offers. Taiwan’s innovative capacity and efficiency relevance to the challenges of globalization has yet to be fully exposed; Taiwan has demonstrated an impressive ability to combat the covid-19 epidemic over the past three years; and with the outbreak of the Russo-Ukrainian war since over the last six months, Taiwan’s special position and geographical location, particularly in terms of key capabilities and key industries such as semiconductor production, has once again become the focus of media attention.

I hope that this joint research project will stimulate more scholars to engage in Taiwan studies, and that the study of Taiwan’s history, culture, society, religion and other aspects will become more in-depth and extensive, so that it can gain a foothold in the German academic community and spread the benefits of Taiwan studies. Lastly, I would like to express my sincere thanks to those who have worked on this joint research project.

TAP — Taiwan as Pioneer A New Research Project

What TAP Is All About?

'Taiwan as Pioneer' (TAP) is an interdisciplinary and interregional postdoc research project. This joint project promotes the structural strengthening and networking of Taiwan research in sinology. The research focuses on Taiwan's role as an innovator in the dynamics of global megatrends.

TAP is funded by the German Federal Ministry of Education and Research (BMBF) for the duration of four years (February 2022 – January 2026).

This research project seeks to establish a cross-institutional network between three universities. Under the head of the Sinology department at Trier University, chaired by Prof. Dr. Christian Soffel, TAP links institutionally with the European Research Center for Contemporary Taiwan (ERCCT) at Tübingen University and the Research Unit for Taiwanese Culture and Literature at the Ruhr-University Bochum.

The interdisciplinary TAP team of postdocs includes researchers from different academic backgrounds, such as political science, anthropology, literature and history, to facilitate reaching out to major disciplines. Besides each postdoc's individual interest, the team wants to combine their academic backgrounds to strengthen the focus on Taiwan.

Why Focus on Taiwan as Pioneer?

For the study of how local innovation interacts with the dynamics of global megatrends in the past, present and future, Taiwan poses an excellent case. Given the fact of a challenging political trajectory, Taiwan presents a perfect case study in many aspects. Influenced by East Asian countries and shaped by Western traders and cultures over the course of several centuries, Taiwan has been tremendously contested in history. Among others, the island has been a port of Jesuit missionaries and served as the administrative seat of imperial Chinese traders and European's alike. It went through Japanese colonial rule and was 'repatriated' as part of the Republic of China in the aftermath of World War II.



TAP's First Network Meeting in Bochum, 11. February 2022

Owing to its favorable location, Taiwan has been on the global political agenda of the great powers striving for influence over the past 150 years. Furthermore, Taiwan has flourished into a vivid melting pot of political, social and civil influences that has created a characteristic trait of facing global challenges with participation and innovation. Today, the innovational strength and social inclusiveness of Taiwan appears as unique as its pioneering status among Asia in general and among Asian democracies in particular. Therefore, TAP team views Taiwan as the perfect case study.

How We Started? – Taiwan as Melting Pot and Innovation Hub

Starting with a preparatory workshop in May 2021, we formed our perspectives in a first publication that was presented at the European Association of Taiwan Studies (EATS) book launch in April 2022. Our first publication is titled 'Taiwan as Melting Pot and Innovation Hub' and was edited by Professor Christine Moll-Murata, who specialised in Taiwan Studies at the Research Unit for Chinese Culture and Literature of Ruhr University Bochum. Here we pictured Taiwan's development into a political, ecological and social pioneer of globalisation.

From the case of quickly reacting against the novel coronavirus and the successful containment of the Covid-19 lung disease in 2020, to a wide-spread promotion of digital infrastructures and innovation hubs – just to name a few – this island is an Asian pioneer in digitalisation and a role model for network societies of the 21st century. With the establishment of a digital ministry under Audrey Tang 唐鳳 (*1981–, in office since 1. October 2016), the government has created new participatory and responsive platforms. Given its world-leading IT and ICT industries, Taiwan has also created both highly efficient channels for detecting disinformation and election manipulation and excellent cyber defences within the administration. Taiwan is essential for the development of global digital transformation, and does, therefore, pose one of the most intriguing case studies regarding the preparedness to encounter the challenges of global megatrends while shaping the development of innovation. Taiwan is a forerunner in numerous fields, e.g., regarding the changes in the era of the

Anthropocene or in terms of the civilizational condition of a compressed modernity. As such, Taiwan's farsightedness has led to many examples in which a political agenda or social trait became institutionalised, such as Amélie Keyser-Verreault's claims regarding the Yuezi Center (月子中心). With a population of 23.6 million composed of at least four ethnic groups living on 36,000 km², there are also interesting pioneering aspects in the field of linguistic studies. A more recent survey showed, 84 percent would be counted as Taiwanese, while 14 percent of Taiwan's population belong to mainland Chinese and only two percent are regarded as Formosan or indigenous. Those figures, however, give little insight on the diversity of dialects and their impact on how challenges of global megatrends are met. Thomas Fliß examines Taiwanese eco-poetry that has emerged since the first half of the 20th century and analyses how poems in dialects, Taiwanese Minnan poems in particular, interlink with the role of self-identification in times of major global shifts challenging the ontological foundation of a national identity. For understanding the development of the pioneering characteristics of contemporary Taiwan, the study of Taiwan's past is essential, We are looking forward to the contribution of our new Taiwanese colleague who will provide unique insights into the contested history.

What Are Our Project Goals?

The TAP postdoc team is composed of interdisciplinary researchers from the fields of political science, sociology, literature and history, so that a connection to major disciplines is given. The team combines eight content-related elements and forms of mediation, which aim at a dialogue both within the disciplines and with the public:

1. Creation of an original subject network with annual conferences;
2. Creation of a shared database accessible to the public;
3. Individual studies on the respective research disciplines;
4. Interdisciplinary synergetic overall analyses;
5. Timely publications of research results in various formats;
6. Preparation of a methodological manual for China studies with a Taiwan focus;
7. Provision of digital teaching modules;
8. Designing a corresponding certificate program.

With this interdisciplinary approach, Chinese Studies with a focus on Taiwan will be institutionally strengthened and its visibility in the German research landscape will be increased.

Project manager

In this project, Dr. Thomas Fliß studies Taiwanese literature and culture in the context of globalisation and the Anthropocene. After graduating in Chinese Literature at National Cheng Kung University in 2020, he worked as an adjunct assistant professor in the Department of Taiwanese Literature at National Cheng Kung University.

Dr. Chien Hung-yi participated in the joint research project at Ruhr-Universität Bochum. In August 2022, Dr. Chien left TAP for her new position at National Cheng Kung University as an Assistant Professor in the Department of History. She will continue to cooperate with the TAP team in the following years.




TAP Activities

TAP team at Sinophone Studies in Europe and the Americas (SEA)

The Research Center for Chinese Cultural Subjectivity in Taiwan organised the second International Young Scholars Conference of the series "Sinophone Studies in Europe and the Americas" (SEA 2022). Hosted by our colleague Barbara Witt at the NCCU, the conference took place from 24-26 March 2022 and brought together participants from Taiwan, Southeast Asia, Europe and the USA. The selected scholars presented their research papers on the conference theme "Borders, Territories, Spaces of the Sinophone World". On Thursday, 24 March 2022, the entire TAP team joined in and reported on the different research perspectives.

During her three days stay, Dr. Perkuhn also met with the team of editors, who are behind the project „Taiwan Insight“ that delivers fact-based articles and provides an active platform for the exchange of a diverse portfolio of information on Taiwan. The network trip provided also the opportunity to discuss TAP’s agenda in more detail and to explore future academic cooperation. For this, it was essential to get in contact with other young scholars, such as Raian Hossain who conducts his PhD project at Nottingham University on Taiwan.

TAP at EACS 2022

The TAP team participated in the 24th Biennial Conference of the European Association for Chinese Studies (EACS), held in Olomouc, Czech Republic, from August 24 to August 27, 2022. TAP successfully composed and presented each members project at the panel “Taiwan’s Innovative Roles in the Global Megatrends: An Interdisciplinary Approach”. In this hybrid panel, Dr. Perkuhn started with her individual project concerning the innovation-driven pathway that grounds Taiwan’s digital democracy today and is a good example for how Taiwan fulfils its pioneering role in the regional East-Asian context. Then, Dr. Chien reconstructed the history of adopting François Gouin’s Direct Method in the early phase of the Japanese colonial rule over Taiwan, tracing the later dissemination of the Method in modern East Asia. Dr. Fliß presented the results of a corpus analysis

dedicated to the rhyme features, and rhyme behaviour changes of Taiwanese rhyme literature. Dr. Keyser-Verreault concluded the presentation round describing Taiwan's institutionalization and marketization of traditional postpartum care.

TAP at Summer Academy

This year, the summer academy of the scholarship receivers for gifted studies (Studienstiftung) took place from 28.08.-04.09.2022 in Heidelberg. The annual topic of the year was „Demokratie im Wandel“ (Shaping Democracy!). Several foundations, such as the Hans Böckler Foundation, hosted workshops for the participants to select. Dr. Josie-Marie Perkuhn contributed to the week's programme with the workshop on “Digital Democracy Taiwan”.

Dr. Josie-Marie Perkuhn contributed to the seminar program of the Hans Böckler Stiftung that offered the Workshop Program „Wege in die digitale Moderne: Visionen und Strategien aus Asien“ (pathways into the digital modernity: visions and strategies from Asia). With about 30 students she discussed Taiwan's innovative approach to democracy and the Taiwan Model that promotes political participation by means of telephone & co.

TAP Travel Grant

Supporting other scholars in their research endeavour to gather knowledge on and experience in Taiwan, TAP called for Travel Grant applications. This year, the project team awarded three promising candidates of different academic background and in different stages at their career. The TAP Travel Grant supports Taiwan-related research projects. Postdocs, doctoral students, and outstanding master's and bachelor's students who conduct independent research projects were eligible to apply. In the end of August, the TAP team selected 3 students for granting the opportunity to do field work research in Taiwan.

The scholarship holder will submit a written report at the end. The results of the research activity will be available to the public and presented at TAP on our website.

Workshop Participants

Prof. Christopher H. Achen

Chris Achen is an emeritus professor in the Politics Department at Princeton University, where he holds the Roger Williams Straus Chair of Social Sciences, Emeritus. His primary research interests are public opinion, elections, and the realities of democratic politics, along with the statistical challenges that arise from those fields. He is the author, coauthor, or co-editor of six books, including the award-winning *Democracy for Realists*



(with Larry Bartels), published by Princeton University Press in 2016, and *The Taiwan Voter* (with T.Y. Wang), published by the University of Michigan Press in 2017. He has also published many articles. Achen is a fellow of the American Academy of Arts and Sciences since 1995, and has received fellowships from the Center for Advanced Study in the Behavioral Sciences, the National Science Foundation, and Princeton's Center for the Study of Democratic Politics. He was the founding president of the Political Methodology Society, and he received the first career achievement award from The Political Methodology Section of The American Political Science Association in 2007. He has served on the top social science board at the National Science Foundation, and he was the chair of the national Council for the Inter-University Consortium for Political and Social Research (ICPSR) from 2013-2015. He is also the recipient of an award in 1996 from the University of Michigan for lifetime achievement in training graduate students and a student-initiated award in 2017 from Princeton University for graduate student mentoring.

Before beginning her doctoral project, she was a research associate at the Institute of Chinese Life Sciences (ICL) at Charité Berlin, working on a database project on Chinese historical healthcare manuscripts. Her research interests include complementary and alternative medical practices (CAM), (medical) diplomacy, science and technology studies, transnationalism, and issues of race and gender.

the law of AI and algorithms, and the security of the technological state. Her research interests include constitutional law, regulation, and human rights law. She holds an LL.M. at the National Taiwan University with her thesis '*Constitut and Implementing the Constitutional Right to Housing: Focusing on Judicial Review*', awarded as the Best Master Thesis of the Faculty of Law at the NTU in 2017. Her doctoral research topic is digitalization and democracy. She has long been concerned with human rights and transitional justice issues in Taiwan and has published publications on transitional justice.

Her future research will focus on comparing regulatory systems (information, energy, climate, etc.) and comparing the laws of East Asian democracies with European laws from the perspective of human rights protection and risk control. She has already presented her preliminary results at international seminars. In any case, the ultimate goal of her research is to make the world understand more about Taiwan and to optimize the democratic and legal systems through two-way feedback. She believes that Taiwan has a wealth of legal issues to study, not only in terms of human rights as a beacon of democracy in Asia but also in digital democracy, which has considerable potential for development. These discussions will enable Taiwan to interact better with the world.

The focus is on a return to post-event publications of primary source material and their contribution to Taiwan historiographical studies.
