M.Sc. Economics

In Trier, you can choose between six different interdisciplinary specializations with optional courses in sociology, business administration, finance, political science, or statistics, for example.

You also have the possibility to take advantage of a

with either Warsaw (Poland) or Bergamo (Italy).

The M.Sc. Economics can also be combined with other master programs of Trier University such as M.Sc. Applied Statistics or M.Sc. Data Science.

Econometrics and Applied Statistics: Advanced methods for data analysis and economic theory.

Environment and Sustainability: A focus on environmental economics and energy markets.

Double Degree Option

Obtain two master degrees from two European universities within two years!

- Spend your first year of studies at Universität Trier and your second year either at University of Warsaw or University of Bergamo.
- From Universität Trier, you receive the M.Sc. Economics European Integration.
- From University of Warsaw, you receive the M.A. International Economics.
- From University of Bergamo, you receive the M.Sc. Economics and Data Analysis.
- The language of instruction is English. The admission into the double master program takes place after the first semester of studies in Trier. Tuition fees abroad are waived for double master students coming from Trier.
