ⁱⁱ As this is a subject-specific language course, native English speakers are not eligible to participate. To earn 5 ECTS credits, students must take both courses per semester. Upon earning all 10 ECTS credits, a certificate will be issued in addition to the grade. Trier students have priority; admission will be announced at the beginning of the semester.
