Introduction:

Preliminary rulings have gained an important role in approximating the laws of the Member States. Their relevance is way beyond guiding the national court on how to decide the concrete underlying controversy. Third parties who are not involved in the proceeding may be affected by the precedent value of the ECJ's ruling no matter where they are located. This workshop/conference will discuss how such bystanders could bring aspects to the attention of the Court which they consider of help for the ruling.

As it stands currently, the access to the Court is allowed to the parties of the underlying case, the European Commission and Members States. Moreover, the Court is supported by opinions of the Advocate General. But are these mechanisms sufficient in the enlarged European Union and the breadth of topics influenced by EU law? The workshop/conference will explore answers on this issue.
