- selbst für ausreichenden Kranken-, Haftpflicht- und Unfallversicherungsschutz sorgt (bitte u.a. Bestätigung ausfüllen und einreichen)
- und folgende Unterlagen vorlegt:
 1. eine Immatrikulationsbescheinigung **für den vorgesehenen Zeitraum** des Praktikums (sofern vorhanden, ansonsten vorab die aktuell gültige Immatrikulationsbescheinigung)
 2. eine Bestätigung des zuständigen Faches, dass das geplante Praktikum (bitte Namen des Unternehmens angeben) im Rahmen des genannten Studienganges sinnvoll ist bzw. ggf. anerkannt werden kann.

Sofern eine Praktikumsvergütung gezahlt wird, ist der/die Studierende verpflichtet zu prüfen, ob im Gast- oder im Heimatland Sozialabgaben und/oder Steuern zu entrichten sind.

Sofern die Praktikumslaufzeit in die Laufzeit des nächsten Semesters hineinreicht, muss ohne Aufforderung die Immatrikulationsbescheinigung (**des selben Studiengangs!**) im AAA eingereicht werden (als pdf per Email ist ausreichend).
